The following suggestions were also given by the members:

- Hon'ble Minister Health & FW Govt. of Odisha will take a review meeting on the functioning of all Red Cross Blood Banks in Odisha., including strengthening the modernisation of the pioneer Central Red Cross Blood Bank, Cuttack and IRCS-OSB proposal for setting up a state level Thalassemia Centre.
- Hon'ble Minister Health & FW Govt. of Odisha will write a letter to all Ministers, MLAs and Secretaries of Deptts. to enroll themselves as members of Red Cross.
- The CCR of all Employees will be introduced immediately.
 - Steps should be taken to tap the CSR funds for more Health & Care activities .

The Director, XIMB will be requested to develop a strategy paper for IRCS-OSB. A project formulation unit may be operationalised to develop more projects in Health & Care

(Care of PWDs).

After the discussion the Chairman took up the meeting seriatim.

Item No. 1 Confirmation of the proceedings of the last Working Committee held on 15.9.2011.

Item No.2 Review of action taken report on the proceedings of the last meeting.

The Working committee reviewed the Action taken report and accepted it.

Item No.3 Admission of all members of all grades to the membership of the Society.

The Committee approved the same and recommended to forward the names to IRCS-NHQ for issue of membership certificate.

Consideration and approval of the actual receipts and expenditure for the period from 1.4.2011 to 29.2.2012 (2011-12),. Revised Estimate for the year 2011-12, Budget Estimate for the year 2012-13 and Annual Action Plan for the year 2012-13.

The committee scrutinized the receipt and expenditure for the year 1.4.2011 to 29.2.2012(2011-12) in respect of the following accounts.

- i. Revenue Account
- ii. Capital Account
- iii. Disaster Preparedness Training Center (DPTC)

On the suggestion of Sri S.B.Mishra, it was decided to increase the current year's expenditure on welfare programme for PWDs by rupees Ten Lakh more and rupees Five Lakh towards project formulation to be carried out with the help of professional agency /institution such as XIMB. The Committee approved the said budget. However, the provision for expected hike in salary/honorarium is subject to recommendation of the Sub-Committee constituted by the Executive Committee (E.C.) and final approval by the Executive Committee. The proposed hike may be considered for all staff members including those who are in consolidated salary / remuneration basis.
